RESOLUTION

September 17, 2025

WHEREAS, on December 20, 2023, the Board of Commissioners qualified EB Employee Solutions, LLC as Third-Party Administrator for Healthcare Reimbursement Account Services, on a project specific basis, for the period of 12/21/2023 through 12/31/2024, with the option to extend for two (2) additional one-year periods, and was assigned Contract No. QP2023-145; and

WHEREAS, on April 3, 2024, a Contract was awarded to EB Solutions, LLC as Third Party Administrator for Healthcare Reimbursement Account Services, for the period of 7/1/2024 through 12/31/2024, in the estimated amount of \$550,000.00, with the option to extend for two (2) additional one-year periods; and

WHEREAS, on September 18, 2024, the County exercised the first of its two one (1) year options and extended the contract with EB Solutions, LLC, for the period of January 1, 2025, through December 31, 2025, in an estimated amount of \$1,700,000; and

WHEREAS, the County of Ocean now wishes to utilize the option to extend the Contract with EB Solutions, LLC for the 2nd one (1) year extension period, from 1/1/2026 through 12/31/2026; and

WHEREAS, the estimated amount for continued services to be provided during this period is \$1,700,000.00; and

WHEREAS, funding shall be made available from Account No. 2026-016-045-4034 contingent upon adoption of the 2026 Temporary County Budget and the 2026 County Budget.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Contract with EB Employee Solutions, LLC d/b/a The Difference Card, 200 Business Park Drive, Suite 311, Armonk, New York, 10504, as Third Party Administrator for Health Reimbursement Account Services is hereby extended for the term of January 1, 2026 through December 31, 2026, in the estimated amount of \$1,700,000.00, with funding available in Account No. 2026-016-045-4034, contingent upon adoption of the 2026 Temporary County Budget and the 2026 County Budget.
2. The Director, Clerk of the Board, County Administrator, County Comptroller or Director of Employee Relations are hereby authorized to execute any necessary additional/subsequent documents.
3. All associated fees due to EB Employee Solutions, LLC d/b/a Difference Card will be paid directly to vendor.
4. Certified copies of this Resolution shall remain on file and be made available for public inspection in the Office of the Clerk of the Board of Commissioners.

5. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to this contract.
6. A notice of this action shall be published once as required by law.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Administrator, County Counsel, County Auditor, Finance Department, Purchasing Department, Employee Relations Department, and EB Employee Solutions, LLC d/b/a Difference Card.
