RESOLUTION

June 5, 2024

WHEREAS, the Ocean County Board of Commissioners has determined that a need exists for Traffic Engineering Professional Services for Installation of New Traffic Signal at the Intersection of CR 17, Route 527 (Whitesville Road) and CR 4 (White Road), Jackson Township, in Ocean County; and

WHEREAS, the Board considers it necessary and desirable to engage a Traffic Engineering Professional Services firm from a list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on February 21, 2024 and referred to as contract number QP2024-50; and

WHEREAS, Colliers Engineering & Design, Inc. is qualified to provide the required Traffic Engineering Professional Services at a not to exceed cost of \$356,920.02; and

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. The Board of Commissioners does hereby authorize the issuance of a purchase order in an amount not to exceed \$356,920.02 to Colliers Engineering & Design, Inc. for Traffic Engineering Professional Services from Capital Budget Account Numbers 301-185-X305-6600, 300-185-X305-6600 and 422-185-X203-6600; and
